Agenda Item #1: Review and Approval of Minutes (December 10, 2020):

Chairman Williams called the meeting to order with a review of the agenda. He moved to the first agenda item of approval for the last COT meeting minutes on December 10, 2020 and

entertained a motion for approval. Councilwoman Scott made motion to approve. Councilman Gilbert seconded the motion, and the minutes were approved by the Council.

Agenda Item #2: DelDOT Update:

Secretary Majeski provided a PowerPoint presentation on DelDOT updates. She briefed and reviewed slides to include: Department Initiatives; Transit Highlights; COVID-19 Impacts on DelDOT Finances; Trust Fund Revenues; Debt Services as a Percent of Revenue.

Chairman Williams asked questions:

Concerned about DMV revenues and if the slowed or non-existent new car market has been factored into the revenues. Secretary Majeski replied by explaining that DelDOT meets with dealers regularly to get updates of where they are. There was an unexpected increase in used car sales in the last three months of the fiscal year which has helped keep revenues up. This is something DelDOT monitors closely and will continue to monitor.

Asked about the current President making frequent trips back home to Delaware, and if the Department gets any money from the Federal Government for the additional operating costs that are associated with staff from DelDOT on traffic control? Secretary Majeski replied by explaining that DelDOT has not seen any type of reimbursements.

Councilman Lessner asked questions:

Asked if the state would be ready to apply for projects once the Infrastructure bill passes, which provides a lot of money for school and pedestrian related projects, and if there is a list of specific projects that DelDOT anticipates on applying for. Secretary Majeski replied by explaining that this bill is something that DelDOT has been very mindful of and preparing for. The Department will announce what projects they apply for once they are identified. Projects will be applied for based on eligibility. DelDOT has an existing Safe Routes to School program in the Division of Planning dedicated to those types of projects.

Agenda Item # 3: FY 23-28 CTP Project Implementation Update:

Deputy Secretary Hastings provided a PowerPoint presentation on project updates. She briefed and reviewed slides to include I-95 Restore the Corridor; 141 Improvement Projects; Camden Bypass; Route 13 Widening Project; Georgetown East Gateway; Route 24 Corridor.

Pam Steinebach provided a PowerPoint presentation on the Biennial CTP Process Timeline and the DelDOT Draft FY23-28 CTP Information. She briefed and reviewed slides to include: Biennial CTP Process Timeline; where to find CTP updates on the deldot.gov website; FY23-28 County Breakdown, New Castle - \$2.03 billion, Kent - \$0.71 billion, and Sussex - \$1.3 billion, with a total of \$4.04 billion.
