Agenda Item #1: Review and Approval of Minutes (October 26, 2022):

Chairman Williams called the meeting to order with a review of the agenda. He moved to the first agenda item of approval for the last COT meeting minutes on October 26, 2022 and



entertained a motion for approval. Councilman Lessner made a motion to approve. Councilman Gilbert seconded the motion, and the minutes were approved by the Council.

Agenda Item #2: Secretary Update:

Secretary Majeski provided a PowerPoint presentation on DelDOT updates. Her briefing included slides on: Safety in Transportation, Safety Legislation Bills; Highlights on Resiliency and Sustainability projects, Transportation Trust Fund- FY24 Sources of Funds; Federal Funds, DMV Revenues, Motor Fuel Tax, SR-1 and I-95 Tolls, FY24 DelDOT Budget, FY25-30 CTP Spend Budget. Department Highlights to include- DART Transportation Improvements, DMV Safety Campaign.

Shanté presented Project Highlights; I-95 & SR 896; SR72 Widening; SR8 & SR 156 Int. Imp.; Plantation Road Imp.; Park Ave Relocation and SR 1 and SR 1261 GSI and Georgetown to Lewes Trail. Current project updates can be found under the DelDOT.gov/projects/ website.

Councilman Lessner asked if there are any future plans to increase police monitoring on roadways and if a separate law enforcement unit is possible. Secretary Majeski responded by explaining that DelDOT will soon begin working with DSP on creating a new DSP law enforcement unit.

Councilman Lessner asked if the rail line is active along the Georgetown to Lewes Trail. Shanté responded by saying, yes, it is an active rail line. Councilman Lessner asked if the Georgetown to Lewes Rail with Trail photo that was shown in the presentation would be an applicable application for the Markell Trail to Newport? Shanté responded by saying that she believes a portion of the trail may be connected and can provide a copy of the concept plans for his review.

Agenda Item # 3: FY25-30 Proposed CTP Projects

Pam Steinebach presented a PowerPoint presentation for FY25-30 Proposed CTP projects as well as the COT Project Prioritization Criteria. Her briefing included potential changes to the prioritization criteria and project summary updates for each county. Shanté also provided an overview of the new project candidates and explained the selection process.
