
***N274, BRACKENVILLE ROAD, SR 41, LANCASTER PIKE TO N258, BARLEY MILL ROAD [Project No. 20-044-01]***

**PROJECT SCOPE/DESCRIPTION:** This project originally scheduled for construction in FY 2004 has been delayed until FY 2006 to review and implement the changes desired by the residents and local legislators.

This project will include pavement reconstruction, construction of ten-foot travel lanes, slope stabilization, installation of partially closed drainage system and crossover pipes, guardrail installation, a two-foot grass shoulders on N274, Brackenville Road from SR 41, Lancaster Pike. There will also be some locations where there will be some stream relocation and placement of rock vanes. It will also include drainage improvements on N258, Barley Mill Road, just north of Brackenville Road.

In the interim, the maintenance section is completing drainage improvements at spot locations along Brackenville Road and the intersection of Brackenville Road and Barley Mill Road.

**PROJECT JUSTIFICATION:** Area citizens have brought narrow travel lanes and safety concerns to the attention of the department.



**PROJECT SCOPE/DESCRIPTION:** This project involves the construction of approximately 900-feet of post and plank retaining wall along the east side of N282, Mill Creek Road from 800-feet north to N278, Mendenhall Mill Road to the first drive on the right.

**PROJECT JUSTIFICATION:** The steep slope on the east side of the roadway is failing, causing a safety issue. The road has been closed to traffic.


***N282, MILL CREEK ROAD AND N276, MCKENNAN'S CHURCH ROAD INTERSECTION IMPROVEMENTS [Project No. 24-041-01]***

**PROJECT SCOPE/DESCRIPTION:** Upon completion of the Project Development phase of this project, it was determined that even with the addition of right-turn lanes, the traffic congestion will not decrease enough to warrant the immediate investment of over \$1,000,000.

An intermediate plan to improve the signal timing and make the signals part of the overall statewide transportation management system will improve the intersection levels of service.

Due to the historic properties and large right-of-way acquisitions that are necessary for an adequate intersection improvement, the “ultimate” improvement of widening the intersection with right-turn lanes and dedicated left-turn lanes will not be completed in the near future. As property becomes available DelDOT will acquire the necessary land for construction.

**PROJECT JUSTIFICATION:** This project will improve traffic flow.

***N282, MILL CREEK ROAD AND N283, STONEY BATTER ROAD INTERSECTION [Project No. 24-041-03]***

**PROJECT SCOPE/DESCRIPTION:** Two options are under consideration to improve safety and traffic flows: realign the northern leg of N282, Mill Creek Road to connect to N283, Stoney Batter Road; or realign both roads and construct a roundabout. A minor amount of right-of-way acquisition along with additional drainage, utility and wetland mitigation, may be required.

**PROJECT JUSTIFICATION:** Increased development in the area has increased traffic congestion at this three-legged intersection. Improvements will ease congestion during heavy traffic periods.



**SOUTHERN NEW CASTLE COUNTY IMPROVEMENTS****PROJECT SCOPE/DESCRIPTION:**

**Southern New Castle County Local Road Circulation Plan [Project No. 21-120-02]** - The joint New Castle County / DelDOT road system study of approximately 101 miles of collector and local roads has recently been completed. This area of Southern New Castle County roughly encompasses boundaries by the Chesapeake and Delaware Canal, the Maryland State Line, the Delaware River and the Middletown surroundings. This area is designated as a sewer service area by New Castle County for phased sewer construction to meet the needs of this rapidly growing area. The study report recommended intersection, road, and operational safety improvements throughout the area. Improvements are to be prioritized and phased in consideration of existing deficiencies, emerging development, and sewer phasing.

**Westtown [Project No. 25-128-01]** – This is a large development proposal for lands located within the Town of Middletown. A tri-party agreement between the Westtown development group, the Town of Middletown and DelDOT has been executed with the purpose of providing for coordination of private development construction with necessary infrastructure improvements to public utilities and roadways. Reconstruction of portions of US301, Bunker Hill Road, Level's Road, Saint Anne's Church Road and Wiggins Mill Road will be undertaken.
