2011 Delaware HPMS Submission Task Force

Based on the data for the previous year, all state highway agencies, including DeIDOT, must submit their HPMS Report individually to the FHWA by June 15th of every year. This is a federal mandate. DeIDOT has complied with this requirement ever since the HPMS came into existence. Each state becomes eligible for its Federal-Aid Apportionment after the HPMS Report is reviewed and accepted by the FHWA.

It is the responsibility of the HPMS Coordinator to review the latest requirements as prescribed in the [HPMS Manual](#), and to familiarize with each item and the scope.

Several changes in the HPMS Manual are incorporated by the FHWA almost every year. In order to keep abreast with the ongoing developments in the process, the HPMS Coordinator participates in seminars and workshops on HPMS. A comprehensive knowledge in the changes in HPMS software is imperative. Above all, the responsibility of the HPMS Coordinator is to collect, analyze, and process the data through a team effort to compile the HPMS Report in its final form in compliance with FHWA requirements. The team effort is provided by **Delaware HPMS Task Force**.
