

The school appears on the 1931 Smyrna, DE U.S.G.S. map. The school was most likely constructed between 1922 and 1925. The Townsend Colored School was one of twenty-three constructed in New Castle County between 1922 and 1925. The school was constructed through a building program established by Pierre S. duPont to provide improved educational facilities to African-American and European immigrant communities.


