## **Preliminary Design Plan Announced For Route 72 Intersections Improvements**

*Dover* – The Department of Transportation (DelDOT) announces that it has selected a preferred design alternative for Route 72, McCoy Road to Route 71 Improvement Project.

On January 23, 2012 DelDOT held a Public Workshop where the public was presented three design alternatives. Over three-quarters of the comment forms received by the Department preferred the two-way left turn lane alternative, which was design option number one. All the alternatives provided two through lanes in each direction along with sidewalks and bike lanes on each side of the roadway.

The project limits will extend from Route 1 to Willamette Drive, and will include work along McCoy Road, Route 71/Red Lion Road, and several other intersecting roadways.

The project will construct an additional travel lane in each direction along Route 72. The rehabilitation and reconfiguring of the intersections of Route 71 and Route 72, Route 72 and McCoy Road, and Route 72 and Wilson Boulevard, will also be included. These modifications are proposed to address capacity issues of Route 72 as well as to address safety concerns. New pedestrian and bicycle facilities will be added to the length of the project.

Another public workshop will be scheduled this fall when the public will have the opportunity to make specific comments on the preliminary plans.


