Bridge

During 1969, the Department initiated an annual bridge inspection program designed to insure that every bridge structure in the State will be inspected by qualified personnel each year. The Bridge Division was responsible for the preparation of an official "Bridge Inspection Manual" outling the requirements of the program and giving details on the inspection procedures.

A brief training program for the inspectors assigned to each County Division Engineer was also conducted. Under the program the responsibility for inspections has been given to the Division Engineers. The Bridge Division will oversee the operations, and act as a consultant when requested.

inspection and maintenance of existing bridges. The preliminary phase of the bridge inventory program, which was initiated in 1966, was completed during the year. Under this program basic data on each bridge was collected and recorded for future reference. The data will be updated as field changes are made.

The purpose of systematic periodic bridge inspections and additional inspection of bridges immediately following any natural or man-caused occurrence which might lessen the integrity of a bridge is to:

- (1) Provide an information base for immediate action to limit use of or to close to traffic any bridge which is revealed by inspection to be hazardous to public safety.
- (2) Determine the extent of any weakness or structural damage, critical or minor, resulting from normal deterioration or any other cause.
- (3) Develop a chronological record of periodic and special inspections listing bridge condition at time of each inspec-



tion thus enabling detection of progressive changes.

(4) Enable bridge maintenance to be programmed more effectively through early detection of structural deficiencies by which the public investment in the highway system will be safeguarded and repair costs minimized.

Through inspection and careful analysis of the facts obtained by the inspection will disclose the ture condition of a bridge, but only adequate maintenance will guarantee uninterrupted traffic flow with maximum safety. The latter actually is the ultimate goal of the bridge inspection program.
